 - Pictures and facial scans, some of which may be considered biometric data under applicable laws
 - Employer information (number, address, contact information)
 - The creditworthiness or other background information

3. Purposes for processing

- The information you provide will be used to provide you with the services you request.
- We will use the contact information you provide to communicate with you.
- We use "cookies" and other electronic tools to collect statistical information about your use of Our websites. This information is used for research and other reasons to better help Our customers by showing Us how We can improve Our websites.
- We do use personal information for Our analytical purposes.

4. 3rd Party Disclosures

- We may provide your information to designated third-party service providers, rental discount sponsors you utilize, Our licensees, and other entities.
- We may sell or otherwise monetize your information to unrelated third parties permitted by law.
- We may share your information for marketing purposes with those with which We have an agreement to do joint advertising, subject to your consent.

5. Security
